Dr. Katherine Dillard Gonzalez explained that there is a new CEO at CaseWorthy and they are confirming a new site visit date. Scheduled tentatively for December 15th. Dr. Dillard Gonzalez discussed the board approved CaseWorthy contract, which has been executed to start NOV 1st, as well as the rates for the contract for the next 3 years.

14. Coordinated Entry and Outreach (CE&O) Advisory Committee Report – Melody Woosley

Melody Woosley reviewed the launch happening in November. This has been the largest change coordinated entry has seen; users have received training on the systems, and everything will be more user-friendly. Review November Launch

Tyler Shoesmith discussed the option of having an open house at the YASS Center. It will be used it to build connections with agencies and partners to leverage more connections with providers to support families in youth. Tyler Shoesmith discussed the continuous work to help support HomeLink and ensure the front-line workers have all the information available, resources, and the HomeLink process through the ESC-20 trainings. Tyler Shoesmith also explained that the YHDP Committee discussed the Identification movement and moving it to the Spring. The Committee is still in the early planning stages.
